- Items must be original with copyright/ownership/right to sell guaranteed by the music therapist.
- AMTA has sole discretion on product placement and reserves the right to reject or exclude items from the Marketplace.
- Products not accepted will be returned and placement fee refunded.
- The hours of the Marketplace are the same as the exhibit hall hours.
- AMTA will be responsible for Marketplace sales.
- AMTA will receive a 15% commission on all sales to cover selling product, processing payments, credit card fee, etc.
- Marketplace participants will receive a sales report and net receipts within 60 days of the end of the conference.
- Conference registration is not included with placement in the Member Marketplace.
