



Barbara J. Crowe

Barbara J. Crowe, Director of Music Therapy at Arizona State University, has contributed to the profession of music therapy for nearly three decades as a clinician, author, educator, and leader in the Association. Her extensive service includes positions as NAMT Vice-President and President, Chair of the Commission on Education and Training, and member of the Assembly of Delegates. She submitted written testimony for the 1991 Senate Hearing "Forever Young: Music and Aging" and worked



with officials on Capitol Hill to write legislation to include music therapy services in the Older American's Act. As an outgrowth of this legislation Barbara directed "Rhythm for Life," which provided group percussion models for older adults across the country.

Currently, she serves as Chair of the Task Force on Sound and Music Healing Organizations, editor of the upcoming AMTA publication, *Best Practice in Music Therapy for Adults, Adolescents, and Children with Mental Disorders*, and author of several publications on the effects of music therapy on human functioning in mind, body, emotion, and spirit. Frances Smith Goldberg

Fran, a music therapist since 1958, was Registered Music Therapist, #97. She received her BMT from Indiana University in 1957 and her Master's in clinical psychology from Lone Mountain College in 1977. After working in state hospitals, Agnews and Modesto, she moved on to Langley Porter Psychiatric Institute in San Francisco in 1971. She became a licensed clinical psychologist in California in 1980. In 1988, Fran began working with Helen Bonny and in 1991, started the Therapeutic Arts Institute. The Institute has provided

GIM training programs in Europe, Asia, Israel, and Bulgaria. The programs in post-communist Bulgaria are offered gratis as a way of giving back to the world community and supporting the growth of music therapy and GIM. 

The AMTA Continuing Education Committee would like to clarify some of the continuing education options available at this conference. Participants can earn five CMTE credits for attending this Conference. CMTE credit is offered for attendance at AMTA Conferences, as AMTA is an approved provider of Continuing Music Therapy Education activities. CBMT Guidelines state that an individual can earn five of this type of CMTE credits per conference with a maximum of fifteen CMTE credits per five year cycle.

It is with much anticipation that AMTA will offer two Specialized Training Courses during the conference. The Specialized Training Courses seek to impart further breadth and depth beyond the fundamental knowledge and skills ensured through traditional CMTE courses. They are specialized in nature in that they focus on a very specific topic, method, and emerging practice area. They provide intensive learning experiences consisting of lectures, case studies, and hands-on clinical experiences by the participant. An individual will earn CMTE credits as well as a Recognition of Specialized Training certificate upon completion of course requirements.

Twenty-six intensive workshops and three Pre-conference Institutes are being offered this year, which are approved by the CBMT. Registrants will receive a certificate indicating completion of each learning experience. According to CBMT guidelines, members choosing this option will need only their certificate for documentation; no summary is required. It is mandatory that you arrive on time and stay for the entire length of each course for credit.

Umbrella groupings can be combined using some of the workshops at this conference. Umbrella groupings are "a group of related workshops, courses, and programs, each fewer than five contact hours, which can be incorporated under a theme or unifying topic relating to the CBMT Scope of Practice and results in a total of at least five contact hours in duration" (CBMT Recertification Manual). Eligibility for this type of educational activity requires documentation from the participant. Umbrella groupings must be completed within a 12-month period. These are not pre-approved activities.

Short event activities are any sessions at this conference which are fewer than five (5) contact hours of learning activity.
